## TREE REMOVAL APPLICATION

- **Electronic Submittal:** The City of Celina is paperless in terms of submittals and resubmittals. All required materials shall be submitted in electronic formats – Adobe PDF (single file) via email; via your dropbox or go to [www.hightail.com](http://www.hightail.com), upload, and send to [submittal@celina-tx.gov](mailto:submittal@celina-tx.gov); or on a CD/DVD or flash drive.
- **Tree Removal Process:** Prior to the removal or critical alteration of any protected trees in the City, an application for a tree removal permit must be submitted and approved, unless otherwise exempt, as governed by the Code of Ordinances. This application is required prior to the issuance of any development related permits. The applicant can request either mitigation option (fee or replacement) for each tree, but the Director has the final approval authority on how mitigation applies to each tree removal application.

**APPLICATION REQUIREMENTS**

**ADDITIONAL SUBMITTAL ITEMS**

- Construction Certification: A statement submitted with the application certifying that all construction methods outlined within the Code of Ordinances shall be followed
- Tree Survey, with the following information:
  - Location Map
  - Identify each tree with a Diameter at Breast Height (DBH) of 6" of greater with:
    - Common Name
    - Scientific Name
    - Whether the tree is located in a floodplain or not
    - Whether the tree is proposed to be removed, transplanted/relocated, or preserved
- Tree Mitigation Table: A table calculating the valuation of each protected tree being removed, both in terms of fee and replacement DBH inches. (Use the Tree Valuation Schedule below)
